Sec. 104.1 Conditions of the Permit- Every permit issued shall become invalid unless the work authorized by such permit is commenced within 6 months after its issuance, or if the work authorized by such permit is suspended or abandoned for a period of 6 months after the work is commenced. One or more extensions of time, for periods not more than 90 days each may be allowed for the permit, provided the extension is requested in writing and justifiable cause is demonstrated. Such extensions shall be in writing by the building official. One set of plans and specification are required.
